Call to Order. Vice President Elizabeth Floyd called the meeting to order at 18:02.

Agenda. The Agenda was adopted as presented.

Approval of Minutes. Members reviewed the 10 December 2024 Minutes. Angela Clifton motioned to approve the 10 December 2024 Minutes. MSgt Keith McMonagle seconded the motion. All in favor.

Treasurer Report. Elizabeth King reviewed the December 2024 Treasurer's Report. The beginning balance for December was \$17,545.86 with withdrawals totaling \$1,708.91 (Raffle, Overnight, competition lunches, boots, and coffee maker). Deposits totaled \$4,605.20 (Old Fashion Christmas, shoes donation, raffle tickets, Amazon return, and Square transactions). The

ending balance was \$20,442.15. Sales from Old Fashion Christmas totaled \$1,763 (\$1,723.31 was deposited after card processing fees).

The Scholarship Fund remained unchanged at \$6,179.91.

Angela Wilkin motioned to approve the December 2024 Treasurer's Report. Linda Persyn seconded the motion. All in favor.

Angela Wilkin made a motion transfer proceeds (\$580) from Veterans Color Run to Scholarship Fund. Elizabeth King seconded the motion.

Angela Wilkin made a motion to deposit \$344.66 (20 percent) from Old Fashion Christmas sales. MSgt Keith McMonagle seconded the motion. All in favor.

Old Business.

Overnight. The Overnight was a success, and cadets enjoyed the taco bar and treats.

Military Ball. The Military Ball is scheduled for 8 February at the Courtyard by Marriott San Antonio Sea World. C/Major Erin Sanders presented requests for 250 card invitations, artificial roses, doilies, ribbon, tulle, and rose petals for this year's Phantom of the Opera themed Ball. She will submit the forms together as she needs to include another item for cadet leadership approval. The ticket price is \$60. Members discussed covering tickets for cadets experiencing hardship. Angela Wilkin made a motion to cover five tickets for cadets experiencing hardship. Linda Persyn seconded. All in favor. Angela Clifton donated decorations that would complement the theme.

The Booster Club typically covers the cost of the floral bouquets for female members of the court. Elizabeth King motioned to approve up to \$400 for bouquets for the Military Ball court. Angela Wilkin seconded. All in favor.
